Objectives:

- 1. To attract qualified students to Quinsigamond Community College and UMass Dartmouth.
- 2. To promote and facilitate an efficient transition of transfer students between institutions.
- 3. To provide specific information and guidelines for transfer students.
- 4. To encourage academic coordination and cooperation, including curricular reviews, on-site visits, and joint academic advising for students attending Quinsigamond Community College.

Stipulations:

- 1. UMass Dartmouth guarantees acceptance of Quinsigamond Community College students who complete the Business Administration-Career Degree Program with an overall GPA of 2.5, or higher as outlined in this document.
- 2. Transfer students designated above will not be required to take more than 68 additional credits to receive a baccalaureate degree.

Mutual Responsibilities:

- 1. Both institutions agree to maintain current listings of the course equivalencies. This will be the responsibility of the two designated representatives.
- 2. Quinsigamond Community College and UMass Dartmouth will incorporate a summary of this agreement into official publications and web sites.
- 3. Quinsigamond Community College and UMass Dartmouth agree to encourage qualified students to participate in this program by providing information, advising and other assistance required to foster a seamless transition from the two-year institution to the four-year institution.

Review/Revision:

1. Both institutions will periodically review this agreement. Substantive changes in the courses or program of either institution will require a review of this articulation agreement. Revisions will be implemented with one year notice prior to termination of the agreement.
