In order for your I-20 to be generated allowing you to study at Quinsigamond Community College, please submit all required documentation. Please submit all qualifying documents as individual PDFs to the international@qcc.mass.edu. Files should not be password protected.

**If you are already in the U.S., the deadline for the fall semester (September) is August 10.
The spring semester (January) deadline is December 10.**

**If you are outside the U.S., the deadline for the fall semester (September) is July 1.
The spring semester (January) deadline is November 1.**

I. Admission

- Complete Admissions **International Student Application Form** online at: www.qcc.edu/intapp.
- Submit **translated secondary/high school diploma or transcript**. If documents are not in English, an official translation must be attached.

II. Qualifying for the Form I-20 (Please submit all documents as individual PDFs.)

- Sign and submit **International Student Acknowledgement Form** (page 4).
- Demonstrate English language proficiency, if English is not your first language.** You may demonstrate this using one of the following methods:
 - 1) Test of English as a Foreign Language (TOEFL iBT:** www.ets.org/toefl). Test results must be sent directly to Quinsigamond Community College. You must achieve the following scores:
 - 173 on the computer-based test or,
 - 61 on the Internet based test or,
 - 500 on the paper based test.
 - 2) International English Language Testing System (IELTS) test:** Students who have obtained a score of 5.0 on the International English Language Testing System (IELTS) test.
 - 3) Duolingo English Test:** Students who have obtained a score of 100 on the Duolingo English Test.
 - 4) US college-level English class:** Completed one semester of a college-level English course at a U.S. college or university, achieving a grade of C or better. Have an official transcript sent to Quinsigamond Community College.
- Certificate of Financial Support** (page 5) stating that your sponsor will be responsible for your educational and living expenses for the duration of your studies at QCC. (You will need an affidavit to present to the U.S. Embassy or Consulate.)

-AND-

- Proof of financial resources**
 - 1) Copy of the original bank document** indicating sufficient resources covering total educational and living expenses for one year. Bank account with minimum balance of **\$35,980.00 (USD)** in a checking or traditional savings account (Up to 2 sponsors). **Statement must be no older than 6 months prior to the application deadline and must be on bank letterhead and include the name of the sponsor.**
 - OR-**
 - 2) Official letter of financial guarantee (from government, foundation, or community organization)**
- Submit a copy of your **valid passport**.

QCC reserves the right to request additional documentation.

III. Next steps for embassy appointment

- QCC will provide you with an I-20 form that indicates you are eligible for a student visa.
- Complete the SEVIS I-901 Fee Form for F visas and submit the SEVIS fee of \$350 (as of October 2, 2024).
- Schedule an appointment with the U.S. Embassy/Consulate.
- Take the affidavit of support, your sponsor's financial statement, the I-20, acceptance letter you received from QCC, and your valid passport to a United States Embassy or Consulate to apply for a student (F-1) visa. (Each embassy may require additional documents.)
- Enter the United States with your F-1 Visa and I-20 form. Come to the Admissions Office at QCC upon arrival (201 HLC). Please plan to arrive at least seven days before the start of your first semester.

All documents must be in English. Documents must be properly sized, formatted and legible.

Please do not send physical documents through a postal service.

All documents should be submitted as individual PDFs to international@qcc.mass.edu.

QCC reserves the right to request additional documentation.

III. Next steps to transfer your I-20 to QCC

- You will receive a statement requesting the transfer of your I-20 to QCC. In addition, you will receive a transfer-in form to be completed by current DSO. (NOT the Acceptance Letter)
- Once the transfer is complete, QCC will create your new I-20.
- Email international@qcc.mass.edu to schedule an appointment with DSO at QCC to sign your new I-20.

*Students requiring a change of status are responsible for completing the form I-539 on their own.
QCC does not provide counsel or legal assistance in completing the I-539 or any immigration documents.*

INTERNATIONAL STUDENT ACKNOWLEDGEMENT

Please read this information carefully before signing this document.

1. International students studying in the United States on visas cannot establish a permanent domicile in the United States no matter how many extensions are granted. All international students must pay out-of-state tuition.
2. We recommend that students take 15 credits per semester since taking fewer credits may require to complete additional semester to finish the selected program.
3. To qualify for and maintain a student visa (F-1 status), students **must complete a minimum of 12 credits in the fall semester and 12 credits in the spring semester**. F-1 students must take a minimum of 9 credits in a traditional, on campus setting. Any credits above 9 credits can be taken online. Winter intersession and summer session classes are optional.
4. International students must demonstrate the ability to read and write in English at a college level. QCC does not offer an ESOL intensive program for international students.
5. International students **must not accept unauthorized employment** or they are subject to deportation.
6. All students must comply with the Massachusetts immunization requirement to take classes at QCC. We encourage you to obtain the required vaccines before arriving in the U.S. You must submit proof of vaccination shortly after the start of your first semester. Please visit www.qcc.edu/immunization for more information.
7. International students cannot directly apply to any certificate and certain specialized health care degree programs in their first semester at QCC due to mandatory program requirements to be in the United States.
8. Students who enroll in classes are responsible for all costs associated with attending QCC. **International students are not eligible for any federal or state financial aid programs, including loans.** Students are billed for each semester. Current semester charges must be paid in full to register for the upcoming semester. Classes can be dropped for non-payment. Students with an unpaid balance may not be able to remain in-status. Payment plans are available.
