This form is primarily for registered students who have a complete financial aid application on file but are still waiting for their award OR who are enrolled in more credits than their award is for.

BEFORE submitting this form you must do the following:

- Verify that you are registered for Spring 2025 classes.
- Check to see if you already have an allowance by logging into The Q, select My Academics, My Finances, View/Pay My Bill.
 - ➤ If a "Bookstore Allowance" is listed under "fees", you may go to the QCC Bookstore website: www.qccshop.com or go to the QCC Bookstore in person to use your allowance. Bookstore hours are listed here: https://www.bkstr.com/gccstore/store-hours
 - > If you have a credit balance but no allowance is listed, this will generally convert to an allowance the next business day. If student loans are a part of your financial aid award, you will only receive a Bookstore Allowance based on those funds when both the Entrance Counseling and Master Promissory Note are received. These requirements are completed at www.studentaid.gov. Once completed, it may take 3-4 days before an allowance is issued. You will be sent an email when a Bookstore Allowance is available.
- If you have not been awarded, verify that your financial aid file is complete by clicking "View Financial Aid Document Tracking" on The Q. If additional documents are needed you must submit them before submitting this
- If you have an award, but it is based on a different number of credits than you are registered for, (compare your actual enrollment to the credit load that your award is based on your award letter or under "Financial Aid Awards" on The Q) check the box below.
